

# Show Us Ya Tents - Terms and Conditions

1. Information regarding prizes and how to enter forms part of the terms of entry. Entries not completed in accordance with these conditions are ineligible and by entering, entrants accept these conditions.
2. The Promoter is Speedcafe.com, ABN: 42 477 494 382, street address: 24/247 Bayview Street, Hollywell Qld 4216, phone: 07 5529 5920, email: info@speedcafe.com
3. Entry is only open only to Australian residents, except directors, management, employees, officers and contractors (and their immediate families) of the Promoter, its related bodies corporate, prize suppliers and agencies associated with this Competition are ineligible to enter. Immediate family means spouse, parent, natural or adopted child, and sibling (whether natural or adopted by parent), whether or not they live in the same household as the employee, officer or contractor.
4. Competition period will be for four days. The competition commences 9am Thursday October 9 2019 and as the last car crosses the line in the Supercheap Bathurst 1000 on Sunday October 13 2019.
